### Summer 2001, CAS Outings

This was a very hot summer, which probably made some archaeology fans stay at home in their air-conditioned homes. Some hard-core folks, nevertheless, participated in our two weekend activities.

Six members and prospective members showed up for the **CU field school** and helped survey a site near Reno towers on Pawnee National Grassland. By that time, the students had already been working for two weeks, and it seemed like an overwhelming task to define the boundary of the by now three and a half mile long site. Our little group was able to do just that. Keri Hicks, the teaching assistant for CU, took us on a tour to show us the site and different projects. Two hearths were being excavated. At the time we were there, they were very scattered, but as they excavated further, one of them looked increasingly intact and a charcoal filled basin was uncovered. After the tour, we proceeded to do the actual survey work.

Overall, they found 10 formal bifaces and one groundstone fragment.

**Bones Galore** was a one-time opportunity for those not only interested in archaeology but also in paleontology. An even smaller group showed up for this event. Dr. Russ Graham, the chief curator for paleontology at the Denver Museum of Nature and Science, introduced us to this famous place, which he started to investigate in 1997. Since then, an enormous amount of bones have been recovered from this site near New Raymer.

The procedures used in digging were very similar to archaeology. We spent days digging, mapping and collecting data. Bones Galore is an appropriate name, for we found abundant bones, teeth, and even a rhinoceros horn. Animals of the Oligocene Epoch, frequenting our area, were mostly rhinoceros, giant pig, brontothere (rhino like, but not true rhino), mesohippus (a three toed small horse), some smaller mammals, etc. The bones date back to approximately 35 million years.

Those members, who returned for a second 'shift', later in the week, were fortunate to also visit "Tortuga Flats", an newly discovered site, littered with turtle carapaces. We unearthed and jacketed a big turtle.

Three different media crews showed up and to their surprise, one of the reporters found part of a skull just lying there in the sun.

It was a fun summer. Thanks to all who came along and helped!
