## November Meeting

#### The Watts Clovis cache--discovery and context

The November 19<sup>th</sup> program will be presented by Bob Patten at the Fort Collins Museum. He will talk about finding a cache of Clovis artifacts in the Ft Collins Pioneer Museum archives. Comparable tools from other Clovis-era caches will be compared to understand the lessons and significance of the artifacts.

**Bob Patten** learned flintknapping on his own, but has benefited greatly from evidence left by the "ancient ones." NOVA's *The Search for the First Americans* included a demonstration by Bob of making a Clovis point. Bob has worked with many archaeologists in puzzling out ancient technological secrets. Bob's book *Old Tools—New Eyes: A primal primer of flintknapping* details the craft of flintknapping. His next book, *Peoples of the Flute: A study in anthropolithic forensics,* will show why early people made the technological decisions they did. Since 1964, Bob has demonstrated flintknapping at the Loveland Stone Age Fair anually on the last weekend of September.

# Minutes of meeting October 15, 2003 Colorado Archaeological Society, Northern Colorado Chapter

The monthly meeting of the Colorado Archaeological Society, Northern Colorado Chapter, was held at the CSU Veterinary Teaching Hospital, led by Bev Goering, president.

Bev, Joel Hurmence, and Sid Sather plan to attend the CAS annual meeting this weekend in Colorado Springs. Bev again offered raffle tickets for the donated Navajo rug for sale, with the proceeds to be given to the Alice Hamilton Scholarship Fund.

The Kaplan-Hoover display, "Awakening Stories of Ancient Bison Hunting," is still being finalized by Mary Jo Zeidler, and will be presented at the annual meeting. The chapter has written a letter for Jeff Eighmy to present to the Colorado Historical Society, supporting the application by the River West Community Association, Windsor, for money to buy the bison bone site.

The PAAC class, "Principles of Excavation" is underway, with 9 people registering. Thinking ahead to the next class, 6 people have expressed an interest in having "Colorado Archaeology." The PAAC program was briefly explained for the benefit of those unfamiliar with it. Bev has completed the full course and received certification for that accomplishment, and spoke of the advantages of working towards individual certification. ## Update on CAS Annual Meeting

Members attending the CAS Annual Meeting in Colorado Springs were: Bev Goering, Joel Hurmence, Jim and Mary Jo Zeidler, and Sid Sather.

Mary Jo's presentation, *"Awakening Stories* Puts into Practice the CAS Code of Ethics," was well received. The accompanying traveling display was viewed by many and received numerous compliments. Following is a recap of the abstract:

Members of CAS are guided by a mission statement and eight-point Code of Ethics that outlines ways we can support responsible stewardship of Colorado's archaeological resources. This includes assisting with effective educational programming that raises community awareness about the value in protecting and preserving Colorado's cultural sites. The Northern Colorado Chapter took the opportunity to help generate a successful interpretive program and traveling exhibit on the Kaplan-Hoover Bison Bonebed, a unique Late Archaic bison hunt site near Windsor, Colorado, currently being studied by Colorado State University. The traveling exhibit, Awakening Stories of Ancient Bison Hunting, acknowledges the Code of Ethics stating that members will 'respect the dignity of groups whose cultural histories are the subject of archaeological investigation,' by seeking interpretations offered by three High Plains Indian Nations. Thanks to the willingness and generosity of members from the Northern Arapaho, Northern Cheyenne and Oglala Lakota Nations, a public educational event and private blessing ceremony were held in Windsor to share traditional knowledge of the buffalo, and to honor this cultural site. By raising public awareness for the cross-cultural value of ancient Indian sites near our communities, we hope to strengthen local support for effective site protection and preservation. Only then will the resources and efforts being invested to protect such sites benefit a broader, more meaningful group of stakeholders.

# Colorado Archaeological Society Code of Ethics

Members will uphold State and Federal antiquities laws and regulations.

Excavation of archaeological sites will be conducted only according to professionally accepted procedures developed in consultation with a professional archaeologist and with the written permission of the landowner. The investigator has the responsibility for publication of the results of his/her investigation and for making the collection available for further scientific study.

Members are encouraged to report archaeological sites to the Office on the State Site Report forms. Materials collected from the surface sites shall be catalogued and described in the site survey report. Collected materials should either be deposited with the State Archaeologist's office or made available for scientific study.

Members will not support illegal or unscientifically conducted activities by participating in or condoning the sale, exchange or purchase of artifacts obtained from such sites.

Members who exhibit artifacts will do so in an educational context. Items from burials and objects considered sacred will not be exhibited.

Members will cooperate with the State Archaeologist and other agencies concerned with archaeology and related fields.

Members will respect the dignity of groups whose cultural histories are the subject of archaeological investigation.

Members will not participate in conduct involving dishonesty, deceit, or misrepresentation about archaeological matters.
