

Minutes of meeting, March 17, 2004

President Bev Goering conducted the meeting, and introduced our new family members, the Petersons, represented by dad Bob and daughter Melanie. The approximately 18 attendees introduced themselves. As a courtesy to our speaker, the program was held before the business meeting.

Dick French introduced our speaker, Bob Mutaw, who presented the program about his professional investigations, "The Search for Stout," a ranching and stone quarrying site ordinarily submerged under Horsetooth Reservoir. Following the presentation, Bev announced the death of the regionally well-known flint knapper, George Stewart, of Windsor. She called attention to the last two months of minutes, as well as the treasurer's report, in the newsletter.

Joel Hurmence gave the report on the Scholarship Committee. Last week the committee met to review five applications recommended by Larry Todd. They had been told that the five applicants were a functioning unit, and could not be prioritized, so the committee agreed that each applicant would receive \$200 toward the expenses of presenting papers and posters in Montreal at the end of the month. \$600 of this \$1000 was withdrawn from the Greenacre Scholarship Account. Joel and Jeff Eighmy each donated an additional \$50 at the committee meeting. At the general meeting, Joel made an additional donation of \$38, by declining reimbursement for the chapter's postal box fee which he had paid, and Marian Wemple contributed \$20. That left \$158, which the members present voted to pay from the general account. Since interest rates currently being earned on the money market account are negligible, and we are obliged to maintain the original balance in the account, there was considerable discussion about need and possible ideas for fundraising to obtain funds for future awards. Members were reminded that one of the conditions of the scholarship award is that the recipient is obligated to present a program at our monthly chapter meeting.

May is Colorado Archaeology and Historic Preservation Month. Mary Jo Zeidler has applied for a mini-grant to cover expenses of the Kaplan-Hoover presentation at the Colorado History Museum, but has not heard the results. The new Rock Art Chapter program the same weekend in Pueblo may dilute participation.

Steve Sherman, a new chapter member, is working with Jason Labelle on a survey in Yuma County, in the vicinity of Beecher Island. He is applying for a grant from the State Historical Fund, and would like us to send a letter of support for his application. We gave preliminary agreement to do so, pending more information. If that work occurs, we may have an opportunity for members to participate in fieldwork.

The statewide debate continues, on moving dues expiration date to January for all. We have a current list from the state on the status of our members. The dues we each pay to the state barely cover expenses. The largest portion of state dues goes to support the publishing costs of "Southwest Lore," the longest running publication of its type. Joel has nearly finished the first indexing all of the issues. When that is done, it can be accessed on the website.

Bev made a request for anyone willing to assist on any of the committees to please let her know. We are still lacking a vice president and field trips and fieldwork coordinator. We also desperately need someone to assist with the copying and mailing of the few hardcopy newsletters. The majority of our members receive their copy through email.

Regional events in the near future are CAS Quarterly Meeting April 17 in Montrose; CAS Annual Meeting, Oct. 8-10, Ft. Lewis College, Durango; Machu Picchu Exhibit at the Museum of Nature and Science, Denver. Please submit and application to present a paper at the annual meeting if you are interested.

Two regular meetings remain in this season, April 21 & May 19. The meeting was adjourned.

Code of Ethics

Members will uphold State and Federal antiquities laws and regulations.

Excavation of archaeological sites will be conducted only according to professionally accepted procedures developed in consultation with a professional archaeologist and with the written permission of the landowner. The investigator has the responsibility for publication of the results of his/her investigation and for making the collection available for further scientific study.

Members are encouraged to report archaeological sites to the Office on the State Site Report forms. Materials collected from the surface sites shall be catalogued and described in the site survey report. Collected materials should either be deposited with the State Archaeologist's office or made available for scientific study.

Members will not support illegal or unscientifically conducted activities by participating in or condoning the sale, exchange or purchase of artifacts obtained from such sites.

Members who exhibit artifacts will do so in an educational context. Items from burials and objects considered sacred will not be exhibited.

Members will cooperate with the State Archaeologist and other agencies concerned with archaeology and related fields.

Members will respect the dignity of groups whose cultural histories are the subject of archaeological investigation.

Members will not participate in conduct involving dishonesty, deceit, or misrepresentation about archaeological matters.
